

Bar Council response to the Information Commissioner's Office Consultation on Call for views: ICO25 plan

1. This is the response of the General Council of the Bar of England and Wales (the Bar Council) to the open consultation by the Information Commissioner's Office on "Call for views: ICO25 plan" published on 14 July 2022.¹

Survey Questions

However, its role as a regulator should give prominence to protect people and create a fairer playing field for compliant organisations, particularly those providing essential services (healthcare and legal) over leniency given to business to grow the economy with the use of Artificial Intelligence (AI). Support to steer organisations in ethical development and/or use of data and technology is a critical role to be played by the Information Commissioner's Office (ICO). It is further felt that its role as regulator needs to take a more prominent position.

In relation to the sentiment aspect, we would encourage you to broaden your research to not only carry out quantitative analysis but also to engage with organisations like us to understand the issues through a qualitative focus. The outcomes measure appears to be eminently reasonable although we would invite the ICO to consult the Bar Council on training materials and templates to ensure they are fit for purpose in our profession but more importantly ensure that the Bar would benefit from them.
