In the last few years, members of chambers – including pupils – have been, or are, involved in public inquiries such as the Grenfell Tower Inquiry, the Post Office Inquiry, the Independent Inquiry into Child Sexual Abuse, the Undercover Policing Inquiry, the Infected Blood Inquiry and the Manchester Arena Bombing Inquiry. Members of chambers also regularly appear in legal challenges and appeals touching on matters of significant public interest, including most recently: <i>R (Bridges) v Chief Constable of South Wales Police</i> (lawfulness of automatic face recognition technology); <i>R (Maughan) v HM Senior Coroner for Oxfordshire</i> (standard of proof applied at inquests) and <i>Robinson v Chief Constable of West Yorkshire</i> (duty of care). Members of chambers have been instructed in recent inquests including those relating to the deaths of Dawn Sturgess and Caroline Flack and the Fishmongers' Hall and London Bridge terrorist attacks.</p>
