| <p>3rd Six Pupil/Probationary Tenant: Crime, Extradition and Asset Recovery</p> <p>Applications or expressions of interest are invited for a third-six pupil/probationary tenant ('third-six pupil').*</p> <p>5 St Andrews Hill (5SAH) is one of the leading sets in crime, extradition, and asset recovery. If you have recently completed pupillage, or are awaiting a tenancy decision, we are seeking a third-six pupil with an interest in developing a practice in crime, extradition, and asset recovery.</p> <p>Our extradition team deals with European cases under the Trade and Cooperation Agreement as well as those relating to all other international jurisdictions, including the removal of INTERPOL Red Notices. We appear at Westminster Magistrates' Court and in appeals to the Divisional and Administrative Courts, The Supreme Court, and the European Court of Human Rights.</p> <p>Our asset recovery, forfeiture, and confiscation team has specialised within these areas for many years and are routinely instructed in proceedings in both criminal and civil proceedings.</p> |

There is a particular need within our **extradition practice**. It is not necessary to have previous experience in this area (although it would be an advantage), as full training with extradition supervisors and mentors will be provided.
