# Employed Barrister of the Year in the Public Sector





### John Swords, North Atlantic Treaty Organization (NATO)

John is Legal Adviser and Director of the Office of Legal Affairs for the North Atlantic Treaty Organization (NATO).

John played an active role in negotiating and drafting the NATO Summit Communiqué in June 2021. He also convened and chaired a meeting of the 30 nations' chief legal advisers, which helped to galvanize legal agreement on permissible forms of support to Ukraine during the conflict with Russia.

John has spoken at numerous academic legal initiatives, including events hosted by the American Society of International Law, the International Committee of the Red Cross, as well as at Harvard University and the University of Oxford.



### Aarti Thakor, Charity Commission for England and Wales

Aarti advises on complex and high-profile charity law issues. She has led her team of over 30 people in addressing technical legal issues to help charities nationally and internationally.

Aarti led on the Charities Bill 2021 (now the Charities Act 2022) and has provided written and oral evidence to the House of Lords. She has also contributed to the development of the Charity Commission's practical regulatory standards, which has helped to clarify the law and ensure clear practical implementation.



### Sam Littlejohns, Government Legal Department

Sam is a Legal Adviser at the Ministry of Defence and is also an RAF reservist. Sam has been responsible for providing advice on longstanding litigation with a hostile state. This directly led to the resolution of the dispute and allowed for a parallel resolution for detained dual nationals. He previously worked for the Department of Health & Social Care (DHSC) Legal Advisers on Covid-19 public health issues, leading on important Covid-19 lockdown regulations.

### Charlotte Pope-Williams, Pinsent Masons

Charlotte is a Senior
Associate at Pinsent Masons.
She is one of the few
members of the firm to work
cross-departmentally and is
involved in multiple teams
within commercial litigation,
including insurance,
financial regulation,
pensions, and construction.
Charlotte also frequently
does her own advocacy.

A dedicated champion for access and diversity at the Bar, she regularly speaks at Lincoln's Inn about life at the employed Bar, teaches on advocacy weekends for pupils and new practitioners, and provides mentorship and coaching to junior colleagues at the Bar. She also sits on BACFI's general committee and the Employed Barristers' Committee.



### **Clare Strickland**, Blake Morgan

Clare is a Partner at Blake Morgan and works within its regulatory group, where she is client partner for two of the firm's largest clients. Clare advises professional regulators on the gamut of their regulatory functions, including on regulatory reform and policy development. She is also a mentor for junior barristers and provides support to her colleagues on applications for judicial office. Clare is lead advocacy tutor at Lincoln's Inn and designed the advocacy course that was used as part of the New Practitioners' Programme for many years.

She is an advocate for diversity across Blake Morgan and is the firm's disability and neurodiversity champion and is also a member of the Bar Council's Employed Barristers' Committee.



### Melanie Gavin, Ward Hadaway

Melanie is a Partner at Ward Hadaway and is also the first barrister to become an equity partner at the firm. As part of her work, she developed a diagnostic review of NHS Legal Services, which resulted in enabling healthcare sector clients to assess their own operations to ensure best practice and identify efficiency savings.

Melanie's work here also led to the production of an online tool to centralise knowledge and avoid duplication of legal advice. She is presently providing support to the national NHS programme and helping to improve the landscape of legal services across the programme.

# Employed Barrister of the Year in Commerce, Finance, or Industry







### John Battle, ITN

John is a barrister for Independent Television News (ITN). He was crucial in the production of the Reporters' Charter, which he also drafted. The Charter was adopted by the Ministry of Justice and launched at the Society of Editors' Annual Conference in May 2022.

John led the legal team advising ITV News' investigation into 'Partygate' and advised ITV News on its investigation into abuse in UK gymnastics.

In addition to his work with ITN, John also chairs the Media Lawyers Association.

# Niamh McCarthy, International Airlines Group

Niamh leads a team of competition lawyers within International Airlines Group (IAG) and is responsible for managing the company's relationship with key regulators. She is recognised by colleagues as a trusted and valued adviser, particularly to the senior management team and board. Niamh has acted on matters including IAG's regulatory strategy for responding to the UK's exit from the European Union, judicial review applications related to the Covid-19 pandemic, and major cartel investigations in the UK, European Union, and United States of America.

Niamh is a specialist in European law and was also closely involved with establishing one of the leading international Bar associations for competition lawyers.

## Legal Team of the Year



### Cabinet Office, Commercial Policy Team

The Commercial Policy Team is part of the Cabinet Office's legal advisory team. For the last two years, the team has worked on preparations for the Government's Procurement Bill, which was introduced into Parliament in May 2022. The Bill covers areas such as the human rights records of other states, trade policies, Covid-19 contracting and protection of the NHS, and governing annual public sector spend. It is also one of the first major projects to translate EU codes and concepts into UK domestic law, applying English drafting conventions to an area that was previously regulated exclusively by the EU.

# Government Legal Department, Department of Health & Social Care Legal Team

The Department of Health & Social Care legal team supported the Government through its initial response to the Covid-19 pandemic. The legal team produced more than 90 pieces of secondary legislation and had to tackle incoming litigation, protecting the Government's Covid-19 response and the ability to take further steps in the future if needed.

Described by Professor Chris Whitty as 'remarkable', the team's role was also to ensure that legality and the rule of law were upheld whilst drafting legislation to support the Government's efforts.

# Government Legal Department, National Security and Counter Terrorism Team

The National Security and Counter Terrorism team has advised the Government on a variety of complex matters in support of the protection of the UK's national security.

The team's portfolio has involved protecting the public through preventative legal action in relation to those presenting a national security risk under the Terrorism Prevention and Investigation Measures Act 2011 and in the Special Immigration Appeals Commission, supporting the work of inquests and inquiries which concerned national security or terrorism issues, and successfully defending challenges to decisions based on classified material.

It has also successfully defended appeals regarding important powers of the Security Agencies in the Investigatory Powers Tribunal, High Court and Court of Appeal.

Commander Tuckett has led the Government's development of its own policy and regulatory framework across multiple departments of state. Her expertise was recognised by the House of Lords Defence and International Relations Select Committee, both of which called her as an expert witness.

Commander Tuckett has also led and influenced the debate around the legal use of autonomous warships.



### Maj Neil W Keery AGC, Army Legal Services

Major Keery is legal adviser to Headquarters Standing Joint Command (UK) (HQ SJC (UK)).

He has delivered legal advice on complex UK domestic operational law issues up to the level of an Army Lieutenant General. Major Keery frequently provided counsel on complex issues and has given legal advice on over 200 requests for military assistance across a range of topics.
