## Description and how to apply

QEB Hollis Whiteman is a Band 1 criminal set looking to recruit two probationary tenants to start in the first half of 2024 with a view to a tenancy application in or around September 2024. Successful candidates would undertake criminal work, both prosecution and defence, as well as privately paying cases. We encourage candidates to undertake regulatory work, both professional discipline and crime.

We are also looking to expand our Inquests and Inquiries and Public law practice group and would welcome candidates who are interested in developing their criminal practice into these areas.

We are looking for candidates who excel and have a proven track record in criminal advocacy and who are committed to maintaining a criminal law practice, whilst developing work in associated parallel areas. Our probationary tenants would be working alongside our two second six pupils but would undergo any tenancy application at a separate time in order to ensure a fair and objective recruitment process.

Each probationary tenant would be allocated a member of chambers as a mentor/supervisor and also a mentor who is in silk.

Our website contains details of the type of support that our pupils can expect to receive and of our commitment to the welfare of our pupils. This support will naturally extend to our probationary tenants. These tenancies (or third six pupillages) are unfunded and successful candidates can expect to earn appropriate fees from the available caseload, managed by an exceptional and dedicated clerking team.

In order to meet the demands of our current pupillage timetable, the probationary tenancy will last until the autumn of 2024 and candidates will then be encouraged to apply for membership of chambers.

Please send your CV with details of the work you have undertaken in pupillage to date, and provide two referees including at least one previous Pupil Supervisor.
